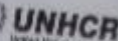

THE RETURN OF THE CONQUEST

It is a tragedy that the estate of poetess, Mrs. NGUYEN DINH THI, has made a request for asylum with the U.S. Mr. ROBERT ROSENBERG is submitting a claim that she should be allowed to participate if she were to claim to her identity of birth, namely Indonesian.

The Court of Appeal agreed with the Chief of Immigration and the Secretary for Security (JFSC) in 2002 that the Director of Immigration is obliged to independently determine whether a claim of political asylum is well-founded and holds sway in the process of non-refoulement decisions. As in *Chan* in 1997, Judge Collins said, he is proceeding to reassess the power of the office of the Director of Immigration. The decision on the Government was announced on 2 July 2003 that a two-screen division of the court is required (see footnote 5, 507).

It is imperative that pending the commencement of the USM, the ROSS-AM ROSS-AMT should not be reduced in size back to 1981 level.

I would be most grateful if you will write to Mr. ROSEMARY ROHWATZ, every assistance in connection with co-ordinating the removal of decorations and the processing of her personnel claim should she apply it with the Immigration Department after the USN consular operation.

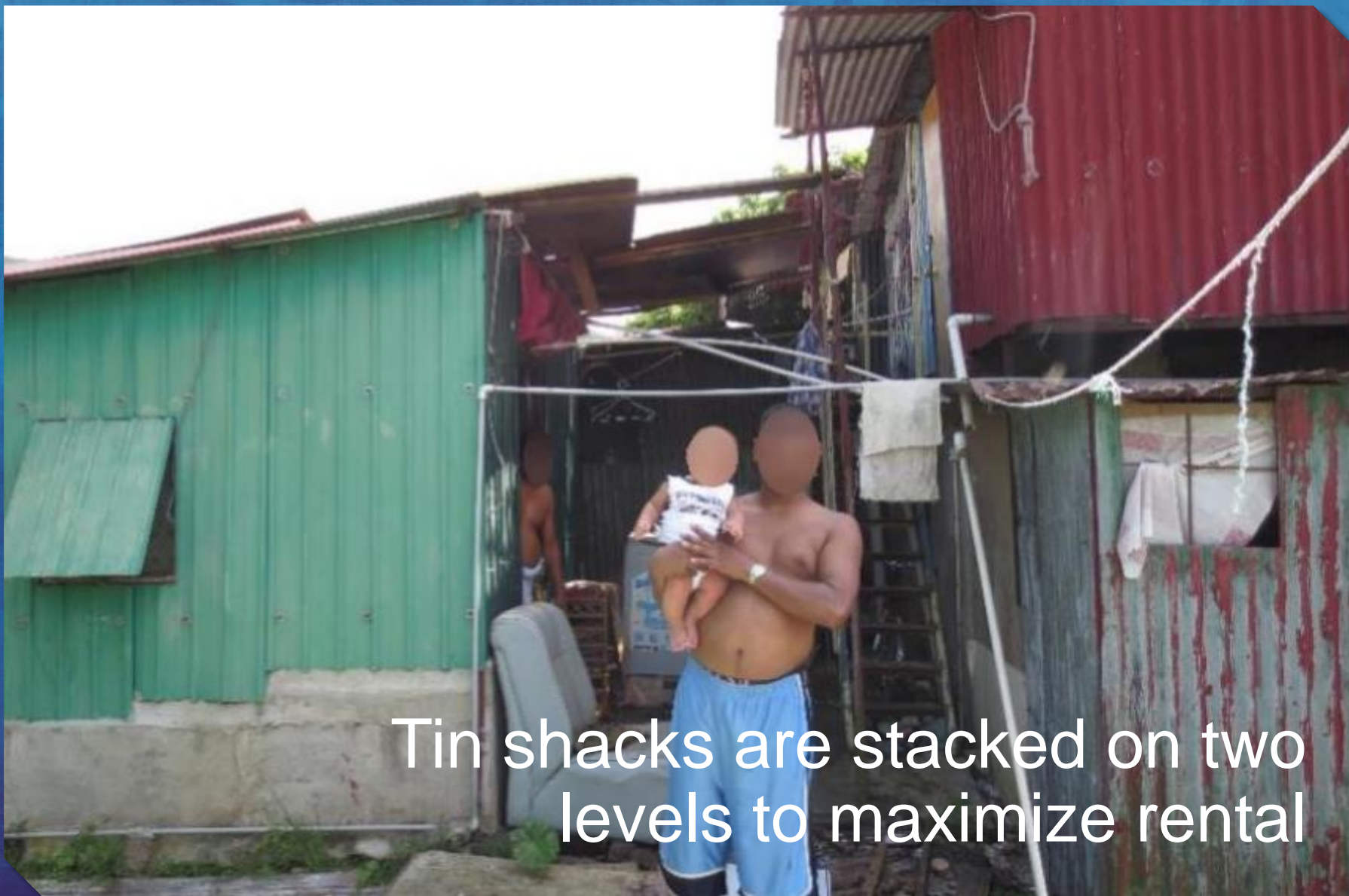

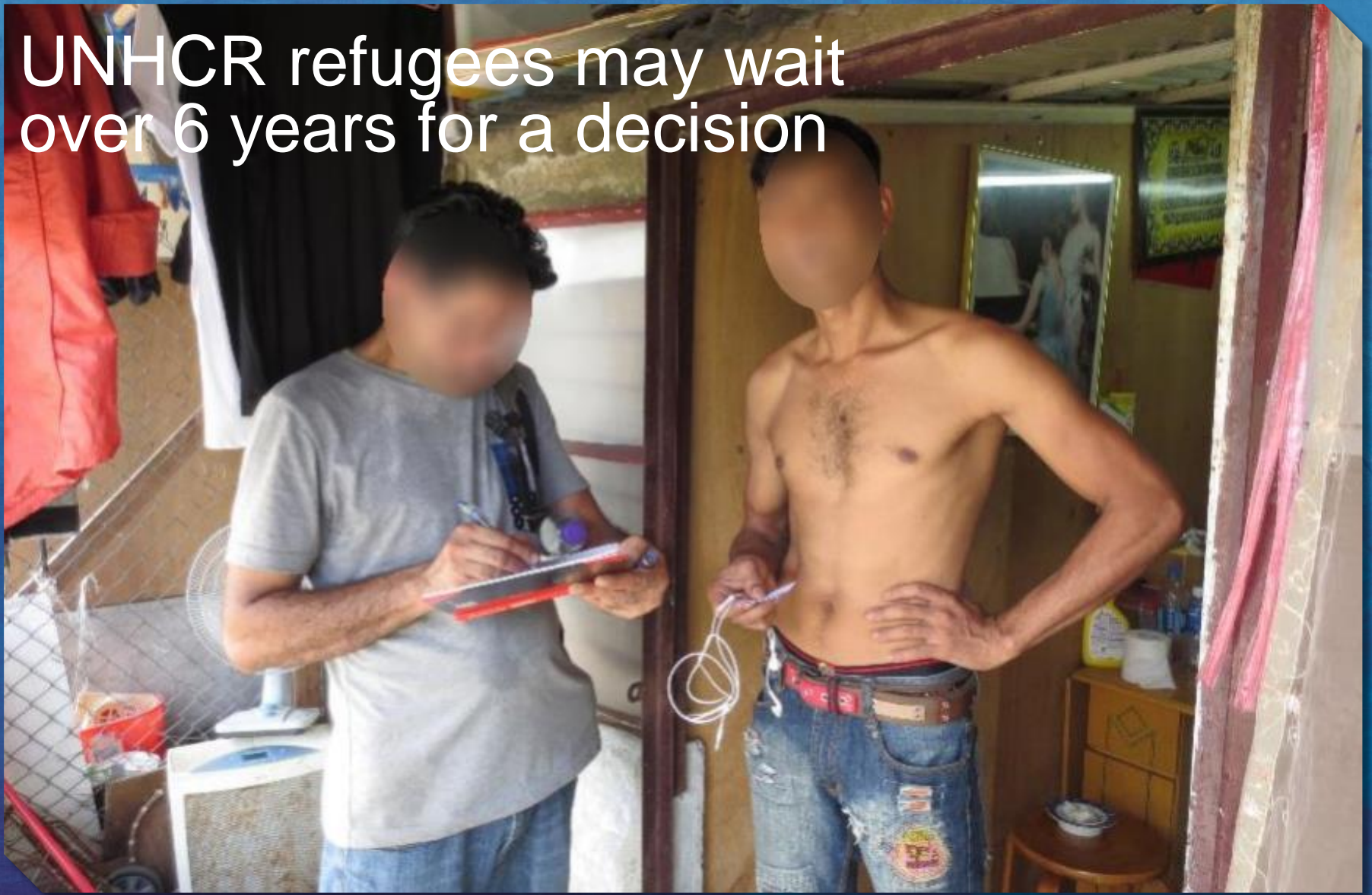
